<u>ORDER</u>

WHEREAS, the Superintendent of Police, Purulia vide his letter Memo no. 1338/DSP (TP)/PLA dated 17-06-2025 has proposed for restriction/diversion of traffic movement in connection with construction work of approach ramp of the ROB at Adra, Beniasole (Raghunathpur side).

AND

WHEREAS, the Executive Engineer, Purulia Highway Division, P.W.(Roads) Directorate also has proposed for the same vide he is letter memo no. 380/W-243 dated 16-05-2025.

AND

WHEREAS, it appears that there are reasonable and sufficient grounds for restriction of vehicles at the proposed place on that road.

AND

WHEREAS, there is alternative route from Raghunathpur Stadium Morh (Raghunathpur PS) towards Kashipur side via Gosaidanga-Barobagan-Manpura Railway Crossing-Adra Railway Town (South Settlement).

THEREFORE, I, Dr. Rajat Nanda, I.A.S., District Magistrate, Purulia after being satisfied that it is necessary in the interest of public safety and public convenience to restrict on movement of certain types of motor vehicles in the above mentioned road as per specifications given below in exercise of the power conferred upon me under section 115 & 116 of the MV Act, 1988 read with order No. 3415(A)-WT dated 30.04.1999 and notification no. 3363-WT/3M-34/99 dated 29.04.1999 of Transport Department, Government of West Bengal do hereby, impose the following restriction on the Motor Vehicles as below to regulate the traffic flow.

Precise location of restriction	Type of restriction	Period of restriction	Alternative route during restriction period
At Raghunathpur Stadium Morh on Hura-Kashipur-Adra road under Raghunathpur PS.	All types of motor vehicles except two Wheelers & Three Wheelers.	One month from 26-06-2025 to 25-07-2025	From Raghunathpur Stadium Morh (Raghunathpur PS) towards Kashipur side via Gosaidanga-Barobagan- Manpura Railway Crossing- Adra Railway Town (South Settlement).

Further to reduce congestion and to ensure public safety in the alternative route there will be additional restriction from 06:00 hrs. to 22:00 hrs. for all types of heavy goods vehicles except those whose destination is the FCI Godown, Adra.

This order is being issued in public interest.
